Additional fees: Extra rehearsal(s) at your request and time spent arranging /composing music will be charged at the rate of \$60/hour per person involved. Performance time extended beyond the agreed-upon terms will result in overtime fees, to be determined and payable at time of service.

Set-up time: We will arrive 20-30 minutes prior to the 'downbeat' in order to check the seating arrangement, set up music, and perhaps warm up for a bit.

Seating: Prior to the event, please determine where you will have us sit. Make sure passersby will have room to move about freely without bumping into us or our equipment. If armless chairs won't be available, let us know.

Attire: We will plan on wearing semiformal attire, but not necessarily black. Let us know if you have a preference in terms of color coordination.

Stowage of instrument cases, coats, etc.: Please inform us of any special considerations as far as stowing belongings safely out-of-sight.

Lighting: Let us know if lighting will be dim, in which case we may need access to an electrical outlet for stand lights.

Weather conditions: We do perform outdoors, preferably under some cover and with a balmy Pacific Northwest temperature of between 60°- 75°F. Under no circumstances will we perform if it means exposing instruments to direct rain, sun, snow, etc., without the refuge of a tent or other shelter.

Cancellation: If I/we become unable to perform this service for any reason whatsoever, I will **1)** try to give you at least six weeks of notice via phone and/or email, except in the case of unforeseen illness or emergency that occurs closer to the day of your event, **2)** refund all fees you have given me up to that point, and **3)** do my best to find a replacement, if that is your wish, or refer you to someone I deem competent to perform the service. If your event is rescheduled, or you decide you do not need our services, we would appreciate as much notice as possible. Upon receiving notice of cancellation on or before _____, I will return your deposit. If you cancel this agreement (or reschedule to a day or time I'm unavailable) after _____, I will expect to receive the minimum balance due of \$_____; we may very well have turned down other performance opportunities by that time.
